Mr Kim Toombs is a Co-opted Governor and is Chairperson. He has been a Governor for 22 years, having held the position of Chair of Governors for 7 years during this time. He is Chairperson of the Finance and Personnel Committee and a member of the Head Teacher's Performance Management Committees. Mr Toombs is the Governor responsible for Special Educational Needs and Disabilities (SEND). Mr Toombs' term of office is 4 years, 14.05.15 - 13.05.19.

Mrs Kathy Russell is a Local Authority Governor and is Vice-Chairperson of Governors. She serves on the Finance & Personnel and Premises/Health & Safety Committees. She has been a Governor at Coalway for 20 years and Chair of Governors for 10 of these. She also meets regularly with all Governors who hold a specific individual responsibility on behalf of the Governing Body.
